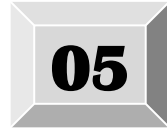

INTRODUCTION

Telemedicine, which merges traditional and modern information technologies, is at the core of many healthcare initiatives. It serves as a tool for increasing patient engagement, reducing costs, and enhancing healthcare accessibility. Particularly for individuals residing in rural areas, telemedicine offers a virtual means to access medical professionals, addressing previous challenges of physical distance. Originating from the Latin words "tele," meaning "to heal," and "medi," meaning "distance," telemedicine is often referred to as "healing by wire," as noted by Time magazine. Once considered futuristic and experimental, telemedicine has now become a tangible reality, firmly embedded in healthcare practices [1,3].

Although telemedicine has recently gained increased attention, it has been in practice for over three decades, with organizations like the National Aeronautics and Space Administration (NASA) contributing significantly to early research efforts. The COVID-19 pandemic prompted measures to curtail the spread of the virus, leading to the postponement of scheduled medical procedures and check-ups. Consequently, individuals refrained from seeking medical services due to fear of contracting the virus. Telemedicine emerged as a lifesaving solution, utilizing communication technology to offer remote diagnosis and treatment [2]. Patients, including those with chronic illnesses and COVID-19, benefited from online counseling, ensuring continuity of care while minimizing the risk of virus transmission. Telemedicine facilitates convenient communication with healthcare professionals via phone or video chat, while email and chat messaging further enhance accessibility to healthcare services. Additionally, remote monitoring offered by telemedicine reduces transportation costs

and decreases the need for in-person clinic visits. In the context of COVID-19, telemedicine proves invaluable for screening, consultations, monitoring nutrient intake, and managing dietary requirements, thereby safeguarding patients from potential infections [4].

RESEARCH OBJECTIVES

1. To explore the significance of telemedicine in the healthcare sector, including its benefits and drawbacks.
2. To assess the impact of telemedicine on patient satisfaction.
3. To investigate the level of awareness regarding telemedicine.

RESEARCH METHODOLOGY

A cross-sectional study was conducted on the general population, utilizing a self-administered survey from March 2023 to June 2023. The study encompassed adults aged 18-60, comprising both males and females, who had access to Google Forms and were willing to complete the questionnaire. The survey aimed to assess awareness of telemedicine, evaluate patient satisfaction with telemedicine, and understand its significance in healthcare. Mailing lists and WhatsApp served as the primary distribution channels for the survey. Employing convenient sampling, a total of 65 respondents were selected for the study. Participants were encouraged to share survey links with their connections to enhance participation. Upon clicking the link, participants were automatically directed to the survey, with no incentives provided for their participation.

RESULTS & DISCUSSION

The study covered a population aged between 18-60 years and investigated the utilization of telemedicine, along with its awareness and impact on patient satisfaction. It examined the perceptions of the Indian population regarding telemedicine and their acceptance of it. Among the various factors examined, the study identified and ranked the advantages (such as time-saving, cost-effectiveness, easy access to health services, and contactless treatment) and limitations (including the absence of a doctor's physical presence, the need for digital literacy, and required technology and hardware) of telemedicine. Additionally, it explored the future prospects and opportunities for telemedicine services and products in the Indian market. The study also shed light on the impact of the pandemic on telemedicine and its utility during the COVID-19 pandemic. The findings revealed certain gaps in patient satisfaction and awareness, suggesting targeted interventions to enhance the overall patient experience and promote the adoption of telemedicine.

CONCLUSION

In conclusion, prior to the onset of the COVID-19 pandemic, the utilization and necessity of telemedicine were minimal. However, the pandemic highlighted the importance of digitalizing healthcare in this era of rapidly evolving technology. Although there has been significant growth in telemedicine investments, the survey indicates that people harbor skepticism regarding the reliability of telemedicine, particularly for critical medical conditions. Many were unsure if their conditions would be accurately diagnosed or if they would receive proper treatment or expertise remotely, compared to an in-person consultation with a doctor. However, this perception is gradually

changing as people become more accustomed to technological advancements and the use of telemedicine, especially following the COVID-19 pandemic.

The majority of respondents expressed satisfaction with their use of telemedicine and acknowledged its significance during the pandemic. They are inclined to continue using it in the future. Most respondents rated their experience with telemedicine as positive. They are aware of its advantages and disadvantages and expressed their intention to use and recommend telemedicine in the future.
